

RESOLUTION OF THE MUNICIPAL ASSEMBLY OF GUAYNABO, PUERTO RICO, AUTHORIZING THE MAYOR OF GUAYNABO, TO EXECUTE AN AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION, UNITED STATES OF AMERICA, FOR A GRANT UNDER THE URBAN MASS TRANSPORTATION ACT OF 1964, AS AMENDED.

- Whereas : The U.S. Secretary of Transportation is authorized to make grants for mass transportation projects.
- Whereas : The contract for financial assistance will impose certain obligations upon the applicant, including the provision by it of the local share of project costs;
- Whereas : It is the goal of the applicant that minority business enterprise be utilized to the fullest extent possible in connection with this project, and that definitive procedures shall be established and administered to ensure that minority businesses shall have the maximum feasible opportunity to compete for contracts, when procuring construction contracts, supplies, equipment contracts, or consultant and other services.
- Whereas : The Municipality of Guaynabo received a notification of grant approval for the construction of 15 Bus Shelters. (Section 18 of U.M.T.A.), dated February 14, 1985.
- NOW THEREFORE : BE IT RESOLVED BY THE MUNICIPAL ASSEMBLY OF GUAYNABO, PUERTO RICO, MARCH 14, 1985.
- Section 1 : That Hon. Alejandro Cruz, Jr., Mayor, is authorized to execute the Grant Agreement on behalf of the Municipality of Guaynabo with the U.S. Department of Transportation, to aid in the financing of a transportation terminal for public cars operating in Guaynabo.
- Section 2 : That Hon. Alejandro Cruz, Jr., Mayor, is authorized to execute such Grant Agreement or any other document required by the U.S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964.
- Section 3 : That Jesus Davison, Administrative Assistant to the Mayor, is authorized to furnish any additional information as the U.S. Department of Transportation may require in connection with the project.
- Section 4 : That Hon. Alejandro Cruz, Jr., Mayor, is authorized to set forth and execute affirmative minority business policies in connection with the project's procurement needs.
- Section 5 : That to the extent that all or any actions hereby authorized have been executed and/or performed by the Mayor all are hereby ratified and confirmed.

Section 6 : Any ordinance, resolution or part thereof which may be in conflict herewith is hereby repealed.

Section 7 : This resolution shall take effect immediately.
