RESOLUTION OF THE MUNICIPAL ASSEMBLY OF GUAYNABO, PUERTO RICO TO SUPPORT THE COURAGEOUS DECISION OF PRESIDENT RONALD REAGAN FOR THE MILITARY ACTION TO PRE-EMPT LIBYAN STATE-SPONSORED TERRORISM BY MOAMMAR KHADAFY.

- WHEREAS : The terrorist activities of Moammar Khadafy in the last six years have cost the lives of thousands of innocent people all around the world; including the 16 Puerto Ricans victims of the Tel Aviv airport massacre several years ago.
- WHEREAS : President Reagan's action ordering an attack against Libyan centers which prepared terrorist actions worldwide is justified as a protective and self-defense measure.
- WHEREAS : Our Governor, Rafael Hernández Colón, stated: "I do not have any doubt the president's decision was a well-thought one. At a moment when step like this is taken, and Puerto Rico being part of the UNITED STATES, we must support the president, regardless of personal criteria we might have".
- WHEREAS : Major Fernando Rivas Dominicci, a Puerto Rican, was one of the victim during the military action against Libya, while piloting the missing F-111.
- WHEREAS : Our soldiers, pilots, sailors, and marines have consecrated with their blood our Island's unqualified American values, and our desire for a permanent union with the United States of America.
- NOW THEREFORE: BE IT RESOLVED BY THE MUNICIPAL ASSEMBLY OF GUAYNABO, PUERTO RICO, AT REGULAR MEETING ON THIS 18TH DAY OF APRIL 1986:
- Section 1 : That this MUNICIPAL ASSEMBLY of Guaynabo, Puerto Rico, support without any reservation the courageous decision of President Ronald Reagan to use military force to pre-empt Libyan state-sponsored terrorism by the worst international pariah, Moammar Khadafy.
- Section 2 : Copies of this Resolution shall be sent to the President of the United States of America, Mr. Ronald Reagan, for his information, and to all communication media for its dissemination.
- Section 3 : This Resolution shall take effect immediately.
