RESOLUTION OF THE MUNICIPAL ASSEMBLY OF GUAYNABO, P.R. TO ASK FOR THE RIGHT-OFF AND/OR RELEASE FROM FINANCIAL RESPONSABILITIES THE MUNICIPALITY OF GUAYNABO IN REGARD TO P-PR-3129 AMELIA WARD- PURSUANT TO PUBLIC LAW 560, 83RD. CONGRESS, AS AMENDED.

- WHEREAS : Pursuant to Public Law 560, 83rd. Congress, as amended, the USA made an advance to the Municipality of Guaynabo of the sum of \$76,280.00 for the purpose of plans preparation of the public work described in the planning agreement.
- WHEREAS : By use of this money, the Municipality caused to be prepared plans and specifications by the firm of Acosta & Vázquez Architects and Lawyers.
- WHEREAS : The Municipality after very careful search of the records have no evidence whatsoever that the plans were used.
- WHEREAS : The Municipality obtained a certification from the designers Acosta & Vázquez stating that their plans were not used for the subject project.
- NOW THEREFORE : Be it resolved by the Municipality Assembly of Guaynabo Puerto Rico:
- SECTION 1 : That the Municipality respectfully request to be released from financial responsibilities in regard to P-PR-3129 Amelia Ward.
- SECTION 2 : Any ordinance, resolution or part thereof which may be in conflict herewith is hereby repealed.
- SECTION 3 : This resolution shall take effect immediately.
