

TO AUTHORIZE THE HONORABLE MAYOR OF GUAYNABO, PUERTO RICO TO DEVELOP A RECREATIONAL PLAN FOR THE MUNICIPALITY OF GUAYNABO, THAT WILL COVER THE NEXT FIVE YEARS AS PREREQUISITE TO REQUEST FEDERAL FUNDS FROM THE URBAN PARK RECREATIONAL RECOVERY ACT OF 1978.

- WHEREAS : The Federal Department of Interior thru the Heritage Conservation and Recreational Service administer the Urban and Recreational Recovery Act of 1978 (UPARR).
- WHEREAS : From the Municipalities of Puerto Rico, the Heritage Conservation and Recreational Services selected seventeen municipalities to participate in the Urban Recreational Recovery Program.
- WHEREAS : The Municipality of Guaynabo was selected to participate in the Program.
- WHEREAS : Thru the Urban Park and Recreation Recovery (UPARR) the Municipality of Guaynabo qualified to request funds for recreation and park rehabilitations.
- WHEREAS : The Urban and Recreation Recovery Program requests a five year Recreational Plan prior to funding.
- WHEREAS : The Municipality of Guaynabo will benefit from this program in meeting with compliance of this requisit for grant application.
- THEREFORE : GRANTED BY THIS HONORABLE CITY COUNCIL OF GUAYNABO, PUERTO RICO, IN SESSION ON JANUARY 15 1991.
- 1st Section: To authorize the Honorable Mayor of Guaynabo to compile a Recreational Plan for the City of Guaynabo that will cover the next five years.
- 2nd. Section: This Resolution will begin to rule immediately and copies of the same will be sent to state, Municipal and Federal Government that will apply.
